David acknowledged the Kaurna and Peramangk peoples of the land we meet on.

Due to the number of absences for the scheduled Board meeting, (Geoff Keynes, Sarah Moulds, John Kemp, Sharon Maslen, Ann Croser), there is not a quorum. The attending Board members decided to still meet, however, no decisions can be made on behalf of the Board. Information was provided on those matters in the Agenda not requiring a decision to be made.

## Action items/Business Arising

EO advised that most items on the action list will need to be deferred until after the AGM as the writing of the Annual Report and other projects (eg Uni SA Loneliness Project) need to take priority.

**Ratios** – Sylvia. The Board Chair determined that this item was best deferred but to be held at a later date due to the high number of Board members absent from this meeting.

**Woodside Cottage Sub-Lease** – Due to the need for a quick reply, this will be emailed to all Board members for their consideration to enable a decision to be reached.

## **Request for Transition Payments from DHS – updates**

- Financial Wellbeing (EFAP). A transition payment of \$23,000 has been granted and expires on 28
  Feb 2024. \$4,200 will be allocated to salaries.
- Community Neighbourhood Development Funding Expression of interest has been lodged. Still awaiting response.

## 'Loneliness Project' with UniSA update

- Hayley will lead this project. Her hours will increase from 0.2 FTE to 0.6 FTE in Jan/Feb
- Seeking to backfill Financial Well-being position. Hours will reduce from 0.4 FTE to 0.2 FTE. In the new (calendar) year.
- The agreement has been signed. Thanks to Pamela for legal advice on this.
- Project will include evidence-based development of podcast, resources and training.

## Strategic Topic – Income Generation

Fundraising Strategy (FS)

This is going to be a critical strategy for us moving forward to address our increasing projected deficit budget and to keep us sustainable in the coming years with less reliance on government grants which are becoming increasingly difficult to obtain.

The four initiatives are:

- Friends of The Hut Family & Friends
- Friends of The Hut Businesses
- Wills & Bequests
- General Donations

Further discussion included:

- The idea of a *"Patron"*. The Patron could call on high net-worth local individuals.
- Invite current sponsors, businesses, Stirling Business Association members and others to a "Thankyou" in March. Potential to engage new sponsors.
- Setting up a *"Foundation"*. A foundation gives supporters something to be a part of. Further consideration required.
- Possibility of holding an event on the platform as a 'launch'.
- Deb Turnbull is interested in meeting 1 on 1 with clients re Wills & Bequests. Seeking feedback on what would work for them, what they wouldn't want to see.
- Christmas Donations. Encourage families to donate rather than giving cards etc.

Action: Deb Turnbull to meet with clients 1:1 to discuss Wills & Bequests.
